At this time there are no reference standards available for (+)- δ -THC. (+)- δ -THC is a different compound from the main (-)- δ -THC cannabinoid and, therefore, these two compounds may have different efficacies. Using the most advanced instruments and techniques available, the separation of (+)- δ -THC and δ -THC is problematic for the scientific community as a whole. PharmLabs believes the unidentified peak to be a combination of (+)- δ -THC and δ -THC with the majority, if not all, of the concentration being (+)- δ -THC. Total (+/-) δ -THC concentration is estimated to be: 56.78%
