Laboratory note: The estimated concentration of the unknown peak in the sample is 4.6%. Currently PharmLabs laboratory can not confirm an unidentified peak in your chromatogram due to interference (only with highly concentrated D8 products) from which we believe to be either (+)-delta8-THC or delta9-THC. At this time there are no reference standards available for (+)-delta8-THC (+)-delta8-THC is a different compound from the main (-)-delta8-THC cannabinoid and, therefore, these two compounds may have different efficacies. Using the most advanced instruments and techniques available, the separation of (+)-delta8-THC and delta9-THC is problematic for the scientific community as a whole. PharmLabs believes the unidentified peak to be a combination of (+)-delta8-THC and delta9-THC with the majority, if not all, of the concentration being (+)-delta8-THC. Total cannabinoids is estimated to be 97.0%.
